States, in order to stipulate the contract with the Organizer, who has engaged Play Sports Travel Srl taking it in as an agent without representation, and therefore the above mentioned agent is not / will not be responsible for the default and/or for problems related to the organization and execution of the sports event and/or the tourist service, which remain entirely attributable to the Organizer/Supplier. GENERAL TERMS AND CONDITIONS

1) Definitions - For the purposes of this contract: "Play Sport Viaggi" means the company Play Sport Viaggi S.r.l. (private limited liability company) Organisation and Promotion of Sports Events and Travel Agency – Share Capital of 10.000,00 euro fully paid-up, based in Via Isei n. 6 - 47521 Cesena (Italy) VAT No./Tax Identification Number/Registration number in the Cesena Companies Register 03835270400/ Chamber of Commerce Business Register No. 318487, provider of requested secretarial/assistance services, vendor of tour packages or services; "client" means the sports association or club, however named, that requests secretarial/assistance services for the participation in the "Event" mentioned in the "Services Request Form"; "Event" (or "Events") means the sports initiative (also called tournament, cup, championship etc.), organized by Play Sport Viaggi or third parties in Italy or abroad, during which sport matches in teams and related cultural and recreational initiatives take place; "Services Request Form" means the request sent by the client to Play Sport Viaggi for the secretarial/assistance services needed to participate in a sports event or for single services or tour packages.

2) Legislative sources - Except for the contract of assistance for participation in events or matches, for which please see the mandate regulations in the Italian Civil Code, tour packages or single services proposed or organized by Play Sport Viaggi S.r.l. are governed by the General Terms and Conditions applied by individual tour operators, establishments or organizing companies and are subjected to Law no. 1084 of March 18th, 1977 for the ratification and execution of the International Convention on Travel Contracts (CVV) undersigned in Brussels on April 23rd, 1970 – if and in so far as it is applicable– as well as to the Italian Civil Code (mandate, etc.), to the Consumer Code as per Legislative Decree No. 206 of September 6th, 2005 and further amendments and to Regional Law of Emilia-Romagna no. 7/2003.

3) Registration and reservation – The Service Request Form is meant as an irrevocable contractual offer with request for "personalized services" and is subjected to the approval of Play Sport Viaggi. If Play Sport Viaggi does not wish to approve it, they will inform the client in writing within 10 (ten) days of delivery of the Service Request Form and they will refund any expenses specified therein, if already paid by the client. The reservation request has to be submitted filling in the specific registration form supplied by Play Sport Viaggi, which has to be filled in completely and undersigned by the client within the set deadlines. The acceptance of reservations takes effect, with subsequent closure of contract, when the Organiser sends notice of confirmation to the client, either physically or by email or fax. The acceptance of registration of the group is subjected to the following conditions: a) The group has to be in possession of the necessary authorization to participate in the event; b) the category of the group must reach a minimum and not exceed a maximum amount of teams to enrol, decided case by case by the sports committee, sports club or organization agency. Reservations have to be made by the deadline given by Play Sport Viaggi, by the person responsible for this as shown in the form, who commits to promptly provide a list of participants, requests for accommodation and whatever else is necessary for the booking to take effect. All information on the service or tour package not included in contractual documents, in brochures/catalogue, or other means of communication including websites, will be provided in time by the Organiser, thus fulfilling their obligations, at their expense prior to the beginning of the services/trips (e.g. tournament rules, name of the Hotel, transportation etc.)

4) Statement of the agreement - Play Sport Viaggi will provide the client with services they requested by sending the Services Request Form, either by post or by email.

5) CLIENT withdrawal. Penitential deposit - The client has the right to withdraw from the contract at any time, as an exception of Article 1373, Section 1 of the Italian Civil Code, by informing Play Sport Viaggi in writing with 7 (seven) days' advance notice. If the client exercises the right of withdrawal, Play Sport Viaggi as penitential deposit will withhold

any amount already paid when sending the Service Request Form. The client can withdraw from the contract without penalty fees if the following conditions are met:

• if the price of the tour package increases by over 10%;

• if there are substantial changes in one or more contractual elements classifiable as objectively essential (tournament, cup, championship etc.) to the use of the tour package on the whole, suggested by the Organiser or notified by the Intermediary after the closure of contract but before departure and refused by the client. In the aforementioned cases, the client has the right: •either to take advantage of a different tour package;

•or to receive a refund of the part of the price already paid. This refund must be issued within twenty working days after the receipt of the refund request. The client has to give notice of their decision (either accepting the changes or withdrawing) within and not later than two working days of the transmission of the notice of increase in price or changes. If the client fails to do so, the proposition made by the Organiser or notified by the Intermediary will be considered as accepted.

If the client withdraws from the contract before departure and the conditions described in the first section are not met, the client will be charged - independently of deposit payment- a penalty as stated by the Organiser of the event/tour package or provider of the tour service, in addition to the cost of administration fees or registration fee (if applicable). As for events organized directly by Play Sport Viaggi, the following penalty fees will apply: 15 € (fifteen Euros/00) per person, up to a maximum of 500 € (five hundred/00 Euros) for each sports group from the moment of registration until 42 calendar days prior to departure; 40% of participation fee from 42 until 7 days prior to departure; 70% of participation fee from 7 until 3 days prior to departure; no refunds will be issued afterwards.

6) Payments - The client, when sending the Service Request Form, will pay the amount shown therein, in addition to taxes as required by law. When booking, the client will pay a down payment of 1000 € (one thousand Euros) for each group, while the final payment has to be made within 30 (thirty) days prior to departure or the beginning of the sporting event. If reservations are made during the 30 days before departure, the client has to make a lump sum payment and attach to the reservation a list of participants, an accommodation request and a list of required services, so that the statement of account can be immediately issued. Failure to pay the aforementioned amounts by the given deadlines, failure to send the documents and the list of services constitute express termination clause, such as to result in legal termination and, in any case, invalidation of the contract, without further notice.

7) Prices - The price of the service or tour package is set in the contract, referring to the catalogue or program not included in the catalogue and any further updates thereof. Price may vary up to 20 days prior to departure and only due to variations in: (a) transportation costs, including fuel costs; (b) fees and taxes on certain types of tour services, such as taxes and landing, disembarkation or embarkation fees in ports or airports; (c) exchange rates applied to the tour package concerned. These variations are based on the exchange rates and the aforementioned fees and taxes in force at the date of publication of the program shown in the catalogue, or the date shown on any update issued in the aforementioned situations. The percentage of increase in the all-inclusive price caused by these variations will be explicitly mentioned in the catalogue or program not included in the catalogue.

8) Changes or Cancellation of the tour package prior to departure - In the event that the Organiser, prior to departure, gives notice in written form that they are unable to provide one or more services included in the tour package, while proposing an alternative, the client has the right either to a refund of the paid amount or to avail himself of a different tour package. The client can also exercise the aforementioned rights if the cancellation is due to a failure to reach the set minimum amount of participants (for the tour package or service) or teams per category (for sports events), as shown in

the Catalogue or Program not included in the catalogue, or in case of force majeure or unforeseeable circumstances.

9) Participant obligations – Participants must have a valid document for entering, passing through, staying in and exiting the country where the event will take place or where the tour package/services will be provided, in addition to any visas and health certificates that may be required. Moreover, they must comply with the common sense rules of caution and diligence, as well as with specific rules in effect in the countries they will travel to, with all the information provided by the Organiser/ Intermediary, and with regulations and administrative and legislative measures. Participants will be held liable for any damage the Organiser or Intermediary may incur due to their failure to comply in the aforementioned obligations. The client must supply to the Organiser/ Intermediary any documentation, information and elements in his possession needed to exercise the right of subrogation of the latter with regard to the third parties responsible for the damage, and they are liable with regard to the Organiser/Intermediary for any damage caused to the right of subrogation. Moreover, the participant will inform the Organiser/Intermediary in writing, when making the reservation or the request of services, of any particular needs that may require specific agreements on travel methods and service performance, if possible.

10) Liability - Play Sport Viaggi is not responsible for events and circumstances beyond its reasonable control, whatever their reason or origin, which may have caused non-performances of third parties with regard to the client during the tournament, cup, organized tour package, events that occurred before, during or after them, during sport matches, related cultural and recreational initiatives and during the performance of services. Play Sport Viaggi will not be held liable for any damage to persons or property deriving from participation in the Event. The client must address any possible complaint to the Tournament Organisers mentioned in the program.

11) Expulsion for wilful misconduct - If one of the trip participants, due to wilful or negligent failure to abide by the rules of proper behaviour and/or sportsmanlike conduct, causes the interruption of business relations between Play Sport Viaggi and the provider of services, they will be prohibited from participating in the future. Any expenses and fees resulting from the willing or negligent violation must be paid by the participant at fault.

12) Accommodation rating - The official accommodation rating is provided in the catalogue or in other documents solely in accordance with express and formal directives received from the competent authorities of the country where the service is supplied. In absence of official ratings approved by the competent Governmental Authorities of the countries, including EU members, which the service pertains to, Play Sport Viaggi reserves the right to provide its own rating of the accommodation.

13) Claims and Complaints - Any breach of contract must be immediately notified by the client in writing so that the organizer/vendor and their local representative or courier can promptly address the problem. In case of tour package, the client has the obligation to file a complaint to the Organiser or Vendor by registered letter with acknowledgment of receipt within and not later than 10 working days to the return from the organized trip, under penalty of forfeiture.

14) Competent Court - All litigations on the contract between the client requesting the services (whether an individual participant or company or establishment etc.) and Play Sport Viaggi or on the performance of said services shall be subjected to the exclusive jurisdiction of the court of Forlì-Cesena.

15) Programme validity period - The programme is valid from 01/01/2020 to 31/12/2020.

16) Processing of personal data - Pursuant to Legislative Decree No 196/2003, please be informed that Play Sport Viaggi processes personal data on paper and/or magnetic medium to perform the Request of Services. Clients provide personal data on a voluntary basis, but the refusal to do so could make it impossible to perform the contract.

As explicit acceptance of the clauses as per articles 6 - (payment), 8 - (changes or cancellation), 9 - (participant obligations), 10 - (liability) 13 – (claims and complaints).

Provided data can be used by Play Sport Viaggi and/or sales operators with whom Play Sport Viaggi entered into agreement for promotional operations, offer of goods or services by mailing lists, transmission of offers and marketing information, transmission of advertising and promotional material, market research, credit management and protection. The Party concerned has the right to obtain from Play Sport Viaggi: a) confirmation of the existence of any personal data concerning themselves, disclosure of said data and their origin; b) erasure, editing, transformation, anonymously or in bulk of data processed in breach of the law; c) update or addition of new data. The Party concerned has the right to know about the processing of data and to oppose it. **Play Sport Viaggi S.R.L., represented by its administrator, is the data owner and data supervisor.**

ADDENDUM – General Terms and Conditions of Individual Tour Service Sale

A) Legislative provisions - Since contracts concerning transportation, accommodation or any other single tour service only cannot be classified as travel organization or tour package, they are governed by the same regulations of these General Terms and Conditions, when applicable and if they are not waived by specific single service regulations.

B) Terms and conditions – Contracts concerning single services are governed by the regulations of these General Terms and Conditions, when applicable and if they are not waived by specific single service regulations. The nomenclature (organiser, travel or trip, transportation) used in the clauses concerning the contract of tour package is intended as referring to the equivalents in the general terms and conditions of individual tour sale (e.g. vendor, stay etc.)
